## 44 COMMUNITY OFFICER REPORTS

Chairman welcomed Ms Kimberley Edmunds, Community Events and Town Support Officer. He then invited her to present her report. Kim referred to her report which was circulated with the agenda outlining events thus far and those organised for the rest of 17/18. All event planning was well in hand commencing with each Thursday in August's Headliners events, followed by Field Day Festival on August 18th. Volunteers for this event are needed to assist with certain activities. The Cookhouse have confirmed they will be providing a bar for the Field Day Festival and Holywell Brass Band have also confirmed they will be playing at all the planned events. Councillor G Sandilands queried the status of the long term sustainability of town events, as it was hoped that volunteers would take on the organising of events after Town Council's initial support. The Town Clerk/Financial Officer cited Prestatyn Rocks which this year is being organised by The Cookhouse as a good example of how this how and: Town Council encourages events to be self Councillor P Penlington asked how the acts were sourced to which Kim explained for this year they were generally acts she had worked with before, and their costs were the most competitive. She had experienced considerable online negativity, however there is a need to refresh the acts booked to provide interest and variety. Councillor A Sampson requested more prominence on Town Council's website for other events in town to which Kim confirmed she would do so but needed the information to enable this. Councillor A Flynn requested that the annual events are presented in a booklet format for 2018 and to be distributed to various outlets in the town. Kim replied this was a piece of work she was

progressing. Kim referred to the plan for 2018 to organise a Pirate event to celebrate North Wales Tourism Year of the Sea. She is seeking external funding to assist financially.

Chair invited Sue Edwards, Community Health and Development Manager to present their previously circulated reports.

- Defibrillator Initiative training still available for those interested
- HLAP Summer activities all booked up with only swimming activity with vacancies. cancelled due have had to be Councillor G Sandilands asked whether the attendance figures were rising to which Sue explained that they were constant year on year. Sue requested members thoughts on whether the unrefunded deposits could be ring fenced to use for HLAP and not contribute to the general pot of funding. Town Clerk/Financial Officer advised that in principle there was no problem with this approach, but that a report would need to be taken to the next Finance and Management Committee meeting in order that Members were clear how that might impact on other initiatives. Town Clerk to action. Councillor R Flynn referenced an initiative called "Every Child Has the Chance to Fly" which may be able to assist with funding
- Dementia Friends Steering Group includes Sue and Steve Fenner at Artisans CIC.
   A drop in service runs at the Old Library every Friday at 2.00pm.
- Mind Music Unfortunately the group had to move premises due to cost of hiring Kings Hall as the lottery funding for this initiative has expired. This makes the future of this initiative uncertain. The estimated cost of continuing is £1,700 - £2,000 per annum. Attendance at the Group sessions have gone down after the premises move from 25 to 7. Councillor Muraca expressed disappointment that the numbers had gone down to such an extent, Sue is using best endeavours to source funding to sustain the initiative
- Men's Sheds Going from strength to strength. They will soon be operating from a workshop on Fern Avenue which was kindly donated to the group by ex Councillor John Morris' widow
- Wales in Bloom The judge was taken to the allotments at Coed y Morfa as part of the route and seemed very positive
- Diabetes Awareness Day The day went very well and has encouraged participation in walking and table tennis
- Cardiac rehabilitation As report, proceeding well
- Food Bank Tesco send donations to Denbigh. In order for Prestatyn and Meliden people to benefit, food donations to be taken to The Old Library (Artisans), Alive Church or any Church

Councillor Sandilands thanked Sue and enquired what funding she had applied for 2018 to ensure sustainability Sue replied none as yet. Councillor A Flynn asked how the message got out to the public to which Sue responded through leafleting etc. Social media was not a good source of information for most of these initiatives as it was generally the elderly population who were not connected to social media. Councillor R Flynn suggested leafleting care/nursing homes, however the issue with that is that they have to be accompanied which entails carers being away from the workplace.

Sue then went on to present Debbie Hughes – Community and Health Development Officer's report which was circulated with the agenda
